opportunities that could strengthen collaboration and ecosystems of the





WDFW Regional Organization






WDFW's Operating Budget

WDFW's BPA/NPCC FWP Funding

- WDFW's BPA funding:
 - Direct from BPA
 - Fish-related: \$2.1M in FY2021, plus capital restoration projects on case-by-case basis
 - Wildlife areas: \$3.28M in FY2021



Implementing the Council's Fish and Wildlife Program:

- Restoration projects
- Fish screening program
- Resident fish program
- Research, monitoring, & evaluation
- Predation management
- Wildlife mitigation



Council's F&W Program

- The Northwest Power Act directs BPA to use its funds to protect, mitigate, and enhance fish and wildlife in a manner consistent with the Council's F&W Program.
- After the Independent Scientific Review Panel (ISRP), the Council recommends projects to be funded through BPA's F&W budget to implement the Council's F&W Program.



Anadromous Fish Habitat and Hatchery Review

 The Anadromous Fish Habitat and Hatchery (AFHH) Project Review is the fourth and last set of reviews of Program funded projects over the past five years. There were 124 AFHH projects and 245 total.



Recommendations on Flat Funding

- BPA should identify projects that are experiencing inflationary pressure.
- BPA should develop flexibility in its budget management protocol.
- WDFW appreciates the recent increase for the coming year.



Recommendations, cont'd...

More generally...

- Monitoring needs to keep up with fish passage routes, (e.g., spillway PIT-tag detectors)
- Fund infrastructure O&M backlog
- Ensure sufficient funding for Comparative Survival Study

- In FY2020, Cost Savings funds were used to address the maintenance needs at the New Cascade Phase II fish screen facility in Ellensburg, WA.
- BPA provided \$220K to WDFW to accomplish this work.
- Eight drum screens were refurbished, including screen upgrades.











Project Example: Blocked Area Mitigation and Reintroduction


Wildlife Areas as Mitigation for Inundation Impacts
